- 2.1 The National Head: Directorate for Priority Crime Investigation is under no obligation to fill the advertised post;
- 2.2 I shall have to submit myself at my own expense and risk to any medical or other tests which are an inherent requirement for the post that may be required to finalize my application for appointment;
- 2.3 I have to provide full particulars concerning obligations to employers and debts if my application receives further consideration;
- 2.4 If my application does not meet the requirements stipulated in the advertisement, my application will be rejected;
- 2.5 If I am short listed I will be be subjected a vetting process. I also agree to submit a set of fingerprints to the secretary of the selection committee.
- 2.6 If I am found to be the final selected candidate for appointment in a post which forms part of certain identified categories, I will be subjected to a vetting process in terms of the prescripts of the Sexual Offences Act, 2007 (Act No 32 of 2007) and the Children's Act, 2005 (Act No 38 of 2005). - 2.9 If I am the final selected candidate I will disclose any financial interest, in the prescribed format, as provided for in the SAPS Employment Regulations, 2018 for newly appointed SMS candidates or proof of the electronic submission for the previous disclosure period, my application may be rejected / my appointment may be reconsidered;
